

NEW HOSPITAL AGREEMENT

This agreement between Elite Veterinary Surgery of Florida, Inc. (EVS) and ______(Hospital) defines the terms of services to be offered.

EVS agrees to offer veterinary surgical services in the Hospital at the request of the referring Veterinarian, who is an owner or employee of the hospital.

EVS WILL PROVIDE THE FOLLOWING:


- A board certified veterinary surgeon with knowledge and expertise in the procedures to be performed
- All equipment necessary for the requested procedure, with the exceptions listed in the section below
- Table drape, gowns, gloves, instrumentation and implants as deemed necessary
- Nocita
- Cautery and suction, if necessary
- ECG monitor, if necessary
- Surgical report and discharges prior to leaving hospital
- A surgical price list and estimates for specific procedures on request

ITEMS OR SERVICES EXPECTED TO BE PROVIDED BY THE HOSPITAL INCLUDE:

- Technician to administer anesthesia
- Suture materials (unless previously discussed) we do carry specific suture for select cases when needed (large gauge PDS, etc., at an additional charge)
- IV catheter and fluids
- Anesthetic agents, machine and monitoring equipment
- · Dedicated clean clipper and blades for shaving
- Sterile saline lavage
- Sterile bowls and gauze and 4% chlorhexidine scrub for surgical prep
- Pre- and postoperative pharmaceuticals (antibiotics, pain medications except Nocita)
- Assisted recovery devices including e-collars and slings
- Bandage materials (including cast material if needed)
- Pre- and postoperative radiographs
- Preoperative blood work

Preoperative blood work should be performed **AT LEAST** 24 hours prior to surgery.

All patients should arrive at the hospital at least 2 hours prior to surgery to allow sufficient time for catheter placement, premedication, etc.

Patients should be food fasted starting at 10 pm the night before surgery. Water is fine until the morning of surgery. Morning medications should not be given, unless previously discussed.

Radiographs should be approved by EVS ahead of time to confirm the appropriate surgical plan.

Nocita: Nocita offers local pain management for up to 72 hours. This medication is included with orthopedic procedures and offered to all other surgeries. The cost is \$200 bottle (our cost) and can be split between several patients, but must be used in a single day. Please discuss this with your client in advance. With the exception of canine cranial cruciate ligament surgery and feline declaws, this is an off- label use of the medication.

Surgical Consent Form: All patients must have an EVS surgical consent form signed prior to surgery. This can be found on our website (www.elitevetsurgery.com). Please have the form printed out and ready for the owner to sign at their arrival. It is advised to have the hospitals own anesthesia consent form signed as well.

Cancellations: Cancellations less than 24 hours in advance will result in a \$200 cancellation fee. A surgical deposit at the time of scheduling is advised.

Payment: Payment for surgical services performed by EVS will be kindly expected upon services rendered the day of the surgery. Cash, check or credit cards are the current accepted methods of payment.
